

Supporting CSDR 'Settlement Discipline Regime' Compliance

The Central Securities Depository Regulation (CSDR) has introduced a Settlement Discipline Regime (SDR) that deals mainly with the regulation of Europe's settlement systems. This remit includes measures to improve settlement efficiency, introducing significant cash penalties for trades that fail to settle on time. Among these measures is the provision for mandatory buy-ins with very direct risk management consequences for market investors, intermediaries, and liquidity providers.

For many firms, pre-settlement and failed trade management lacks automation, with parties often relying on dated or cumbersome trade report portals or reports. With a mandatory buy-in deadline being imposed of T+4 (for equities and fixed income securities) the operational timeframe for resolving failing trades is being significantly compressed. Greater automation is essential in order to bring the processes under control, maintain operational efficiency and mitigate the buy-in risk.

SureVu safeguards buy-side and sell-side firms from falling foul of mandatory buy-ins by extending exception management processing across the full settlement lifecycle. Communicating with custodians via real-time SWIFT messaging, Operations Managers have full oversight of issues within the settlement chain, instantly identifying potential buy-in conditions. With the added security of an automated pre-settlement management process, the chances of trades failing in the first instance are greatly reduced.


A modern dashboard ensures trades at risk are front and centre, supporting management oversight at a glance.




